1. Opening of meeting

4. Project status and field trial, evaluation

a. status update

Mats presented the project status. The field trial is about to end with so far 100-150 students from Finland, Norway and Sweden and a few Italians. Denmark is in production since a week ago, although no student users yet. But hopefully there will be in the field trial. All in all it is expected to reach over 200 students, which is more than originally planned.

EMREX has also continued to be present in many conferences, e.g. GDN, Eracon, EWP and more coming up as e.g. EUNIS and EAIE. Participation has been shared between mostly Mats, Janina, Anders and Geir, although other emrexians have also attended.

b. EMREX final seminar in Nov

EMREX will ha a final seminar in November in Italy. Proposed date is 30.11. Stefano will still confirm the date and location (city), most likely either Rome or Bologna. The agenda will depend on whether EMREX+ is approved or not, but will otherwise be a similar event to the seminar in Helsinki.

c. EMREX+ application

Janina and Mats presented the EMREX+ application, the innovations and partner list. The application was handed in in March and the decision is expected in July. The SG noted that it was a very impressive proposal.

d. Report for 2016

After some confusion EACEA has requested a report also from 2016. The report has just been submitted and basically states that the project is on track.

5. Other Issues

Kaisu informed the SG that she will go on maternity leave and won't be attending the last two meetings. Jukka Haapamäki, also from the ministry, will replace Kaisu. The SG thanked Kaisu for all her good work and wished her and her baby well.

Lene informed via email that the Norwegian Ministry of Education and Research is organising a Nordic conference on recognition of higher education qualifications together with the Nordic Council of Ministers and NOKUT(The national quality
